We have completed another challenging year at the Coalition for Food and Nutrition Security, a multi-stakeholder platform to facilitate cross-platform dialogues between experts, policy, program leaders and agencies with the shared vision of sustainable food and nutrition security in India.

Malnutrition continues to remain a silent emergency in India, even as the government of India has made some concrete efforts to combat the issue. POSHAN Abhiyaan in its new avatar focuses on some key areas that include alignment with AYUSH, leveraging traditional knowledge systems, focus on aspirational blocks and establishment of Saksham Anganwadis, to provide a safe space for children to thrive. Malnutrition, in all its forms, carries a huge direct and indirect cost to individuals, families and the nation.

This year, the Coalition has completed phase -2 of the project 'To drive a child-centric and community focused narrative for Community-based Management of Acute Malnutrition (CMAM) and treatment of SAM children in India' with UNICEF and CIFF. A no-cost extension was affected from February. The project aims to achieve consensus amongst key stakeholders regarding urgency to address (Severe Acute Malnutrition) SAM, and roll out a comprehensive approach to the CMAM program in the country. Mainstreaming CMAM within the government healthcare and ICDS systems is crucial to ensure every child benefits from good nutrition and has the opportunity to grow into a healthy and happy individual.

To lead engagement and advocate for pro-poor policies among key stakeholders, elected representatives and policy makers, the Coalition engaged with several Parliamentarians, key policymakers at national and state level, development partners, CSR and civil society leaders. National Technical Committee (TAC) meetings, Core Advisory Group (CAG) meetings and webinars were held for nutrition advocacy and policy action, in tandem with state UNICEF offices for joint advocacy with the Government counterparts. State Consultations on addressing malnutrition and perpetual wasting have been held in the project states of Assam, Odisha, Madhya Pradesh and Jharkhand, and the recommendations that emerged in consultation with development partners, Coalition members and stakeholders have been presented to the government.

The Coalition is in continuous coordination with Social Welfare, UNICEF, Development partners, States Centre of Excellence (CoE) as well as Civil Society networks for SAM management. We have developed a Manipur Nutrition Action Plan, and similar proposals to address malnutrition in Jharkhand, tribal districts of Odisha and Chhattisgarh, and exploring projects on nutrition-focused disaster management.

We are grateful and would like to thank all those who have shared the programmatic information and evidence. The valued partnership has amplified stakeholder engagement, and created an ecosystem for better policies and programs in India. I am thankful to the Governing Board, team members and the staff, who put consistent efforts to make the best possible use of information received and make the Coalition grow.

Our Vision

The Coalition in its second decade is a platform for members to collaborate and achieve the common vision of “sustainable food and nutrition security for all.” Unique and unparalleled, the Coalition has elected a Governing Board which includes senior functionaries from the Government of India, State governments and eminent civil society leaders.

The Coalition has the inherent strength as a public interest-oriented organisation to transform the food and nutrition landscape. This strategy aims to transform the country’s nutrition scenario through collective action, keeping sustainability as the key approach, placing women and girls in the forefront. The methodology involves a series of consultations, in- depth interviews, feedback from the thought leaders and practitioners from across India and the world, discussion and approval in the General Body.



The Coalition functions as a knowledge aggregator, collating existing research coupled with on-field programs, and transferring the knowledge to partners and stakeholders. The Coalition strategy involves collaboration, influencing policy for improving state accountability vis-a-vis SDG targets, and providing informed choices on policy reforms, breakthrough research, and strategic priorities in its pursuit of evidence-based advocacy.

These have been achieved by sustained and inclusive membership engagement, knowledge management designed for advocacy and to catalyse social behaviour change.

Our Manifesto and Mandate

Our strategy for the next 5 years will be to ensure that sustainable food and nutrition is a priority agenda not only for the government, civil society and other development actors, but also for the socially responsible businesses, media, aid agencies and citizens at large, particularly the women and girls. Guided by the belief that women play a strategic role in protecting food and nutrition sovereignty, we will work to empower women with research backed information, tools and methods to bring changes in their human conditions and social positions. The Coalition will be guided by the concern that even as the increasing food demand is met, the natural resources will be used responsibly.

Activities: April '21-March '22

Dialogues on Nutrition

One of the key mandates of the Coalition is to keep the dialogue and discourse on the multi-sectoral nature of nutrition in the spotlight. In April 2021, CFNS, Tata Cornell Institute (TCI) and BAIF Development Research Foundation jointly organised a webinar on “Gender, Nutrition and Agriculture” in the series of web-based policy discussions on themes related to food, nutrition, and agriculture. The aim of the webinar was to strengthen collective efforts to achieve improved nutrition.

A webinar on Cost of Childhood Wasting in India based on the findings of the report on Cost of Childhood Wasting in India was organised with the objective to initiate a discussion on the urgency of focusing on wasting in India.

Along with Coalition member EFICOR India, CFNS held discussions to propose the setting up of a platform to discuss the Implications of Climate Change on Food and Nutrition Security towards achieving the United Nation Sustainable Development Goals 2030 targets.

Jharkhand

The Coalition, along with UNICEF and IPE-Global, initiated the use of the C2IQ (Coverage, Continuity, Intensity, Quality) and We-Can platform for capturing the field monitoring of essential food and nutrition services through development partners, involving the State department of WCD/State Nutrition Mission. CFNS also supported the Department of Rural Development and Panchayati Raj, Jharkhand in building capacities of frontline health workers on nutrition and community-based care of children with moderate and severe acute malnutrition, and their role in the process.

Mainstreaming millets for nutrition security in India:

In June 2021 CFNS participated in the consultation on the technical, operational & managerial aspects to introduce millets in the food model of Hot Cooked Meal. There was an e-launch of “White Paper on Millets – A Policy Note on Mainstreaming Millets for Nutrition Security in India.”

Meeting of Technical and Advisory committees

In June 2021, CFNS organized a virtual meeting of the National technical Committee on CMAM at the national level with an aim to build the momentum and to collectively take key activities of the NTC forward.

In July, 2021, the National Core Advisory Group met virtually and updated the plan of action for the Phase-II of the program “To drive Child-centric and community focused narrative or community-based management and treatment of SAM children in India”. Initiatives of State WCD for Management of SAM in context of Covid- 19 were discussed that included tele-calling initiative in Assam, tele- monitoring survey in MP, pushing ahead the ‘SOPAN’- Strategy for Odisha’s Pathway to Accelerated Nutrition and to work towards Strategic Action to Alleviate Malnutrition and Anaemia Reduction (SAAMAR), a nutrition mission proposed by the Jharkhand government.

Advocacy Action

In August, 2021, CFNS organized nutrition sub group meetings and presented advocacy efforts in the context of Commitment to Action (CTA). Two sub group meetings in this connection were organized in which CFNS stressed the need to ensure uninterrupted, universal, and high-quality coverage of services and accelerate efforts to address both nutrition sensitive and nutrition specific interventions.

CFNS as a media partner provided support for the advocacy efforts for CMAM in Jharkhand.

Webinar on “Ma ka Dhoodh Paryapt nahi? IMS Act”

CFNS in partnership with Department of Women and Child Development organized a webinar on “Ma ka Dhoodh Paryapt nahi? IMS Act” in August, 2021. Exclusive breastfeeding for the first 6 months of the child’s life ensures nutritional security as breast milk has all the essential nutrients required for growth. A child should be allowed to take its mother’s breast milk within one hour of birth. The first milk or colostrum is rich in immunoglobulins which provide essential nutrition and strengthens the immune system of the baby.

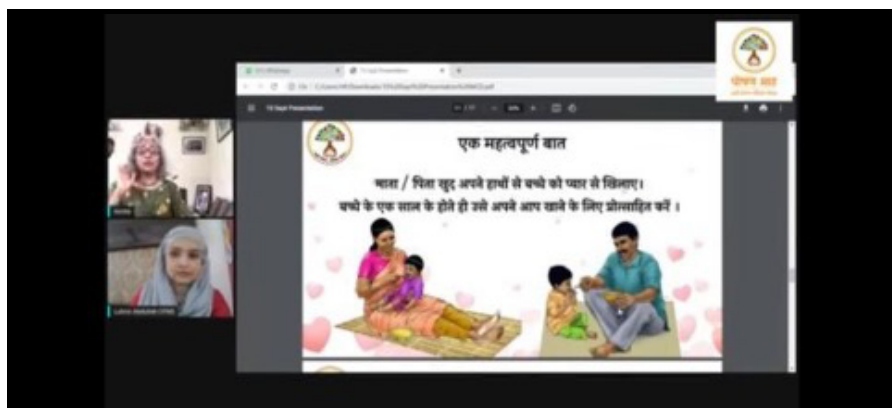
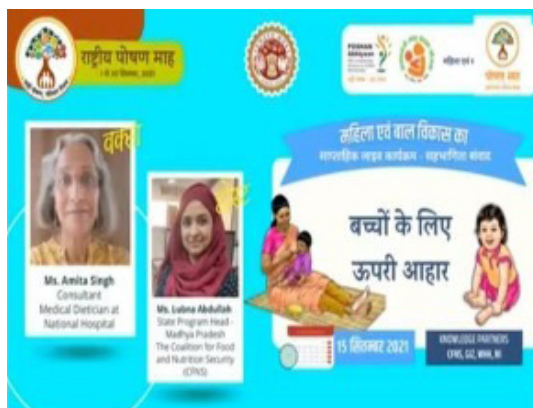

World Breastfeeding Week Activities in Madhya Pradesh: 6 webinars

CFNS extended its support to the Directorate of Women and Child Development, Madhya Pradesh in facilitating six webinars during the celebration of World Breastfeeding Week and Nutrition Month.

CFNS in partnership with the Department of Women and Child Development organized a webinar on “Jeevan Ke Pratham 1000 divas” (First 1000 days of life).

CFNS in partnership with the Department of Women and Child Development organized a webinar on “Garbhavastha Ke Dauran Poshan” (Nutrition during pregnancy).



Developing Strategies for COVID-19

CFNS in partnership with the Centre for Gender Studies and Development organized a webinar on “Revisiting Child Development in the Context of Newly emerged Vulnerabilities of Post Pandemic Period.”

CFNS and World Vision jointly organized a webinar on “Child Nutrition services in the Pandemic: Challenges and Adaptations required.”

CFNS facilitated the dialogue in regard to the online Training by Welthungerhilfe and UNICEF. The training was an Orientation session for the Frontline workers and Volunteers on COVID-19 Wave 2.0.

Poshan Maah Activities

A national webinar was organised on “Identification and Services for Children with SAM children” a priority during Poshan Maah. Director DSW- Assam, Joint Director -WCD- M.P. & National Technical Expert-NCoE, New Delhi participated in the webinar and highlighted the holistic and innovative approaches required to manage SAM.

1. CFNS, UNICEF and Save the Children as part of IM-SAM came up with the first draft of the SOP on Community Therapeutic Centres under POSHAN 2.0 guidelines.

Engagement with Government

2. CFNS prepared responses for Lok Sabha on 10 questions on CFNS efforts in reducing hunger, malnutrition and anaemia.

Knowledge Products

3. CFNS developed knowledge products on success stories of Nutrition Champions from Madhya Pradesh and Stories of Change from Odisha, Jharkhand and Assam.
4. CFNS held 10 community meetings to choose/Identify a Nutrition Champion among the active opinion leaders from all caste and class groups.
5. Mukhyamantri Baal Arogya Samvardhan Karykram Annual Report 2020- 2021, that was prepared by DWCD, MP in collaboration with CFNS & UNICEF India was subsequently released by Honorable Chief Minister- Madhya Pradesh Shri Shiv Raj Singh Chauhan.
6. Webinar with World Vision on Child Nutrition Services during the Pandemic. In June 2021, CFNS and World Vision jointly organized a webinar on “Child Nutrition services in the Pandemic: Challenges and Adaptations required.” CFNS was also engaged as the key panelist and consensus on community-based management of acute malnutrition was built.



National Core Advisory Group Meeting

The National CAG was held virtually in July. It was proposed to prepare a policy paper that targets severe forms of malnutrition that covers background and current status of malnutrition in India, especially the time trends in moderate and severe form of malnutrition. High focus to be given to children from 0-6 months of age as there are highest chances of mortality. This critical period has not been adequately covered under the Poshan Abhiyaan. Discussion on biofortified crops. Promoting indigenous crops, clarity on identifying SAM children, feeding practices, maternal nutrition, helping anganwadi workers in micro-planning, promotion of animal rearing and non-vegetarian food, as well as promoting diets with all food groups was discussed.

Webinar on “Nutrition during Pregnancy”

Webinars were organized in partnership with the Government of Madhya Pradesh in the month of September 2021. CFNS in partnership with the Department of Women and Child Development organized a webinar on “Nutrition during Pregnancy”. CFNS and the Centre for Gender Studies and Development organized a webinar on “Revisiting Child Development in the Context of Newly emerged Vulnerabilities of Post Pandemic Period”

Community meeting with mothers' groups

A community meeting was organized on 9th November 2021 at Anganwadi centres in Akola village, Sohagpur block, Hoshangabad district of Madhya Pradesh.

The meeting with participation from mothers discussed socio-demographic details of the village, health and nutrition services, challenges faced by them, living pattern of the families, nutritional status of children, and status of CSAM implementations.



Second Technical Advisory Committee (TAC) Meeting

In September 2021, CFNS organized the 2nd TAC meeting in phase II with an aim to build the momentum and to collectively take forward key actions agreed to by the technical committee. Framework for Opportunities & Challenges for Institutionalizing Community based Management of SAM was put forward by CFNS for the discussion on Mapping of Production Units, which was shared with the members for their suggestions and support. Documenting the experience of CMAM implementation and conducting a process evaluation exercise to understand the perceptions of various stakeholders who are at the forefront of a health system.

Advocacy Efforts and Commitment to Action (CTA)

CFNS put forth its advocacy efforts in the context of Commitment to Action (CTA). Two sub group meetings in this context were organized. The purpose of these sub-group meetings was to leverage each other's access to the different Government Ministries or NITI Aayog or Parliamentarians to promote advocacy messaging done by different groups.

MEMBERSHIP ENGAGEMENT and Discussion on Effects Climate Change on Food Security

CFNS and EFICOR India held discussions in January 2022, to propose setting up of a platform to discuss the Implications of Climate Change on Food and Nutrition Security towards achieving the United Nation Sustainable Development Goals' 2030 targets.



Meetings with KOFs and Policy Makers in Project States

CFNS state RPOs in Madhya Pradesh, Jharkhand, Assam and Odisha held meetings with senior government functionaries in the states to discuss CMAM protocols, for stakeholder meetings and message alignment.

In March 2022, CFNS RPO Madhya Pradesh, Pratibha Chaturvedi engaged with former Lok Sabha Speaker Sumitra Mahajan to deliberate on building linkages with village and remote communities, amplifying the promotion of locally available food & recipes in food demos to fight malnutrition and incorporating it with the IMAM program in Madhya Pradesh. Pratibha Chaturvedi met Ms. Alka Srivastava, Member Secretary, Food Commission and discussed strengthening Food Security in families with Severely Acute Malnourished (SAM) and MAM children in Madhya Pradesh.

In Odisha, state RPO Mona Jethwa held a meeting with the Chair, Odisha State Food Commission in February 2022, to discuss on key pathways and strategies to provide a safe space for Moderate Acute Malnutrition and Severely Acute Malnourished children to survive and thrive.



CFNS developed knowledge products on success stories of Nutrition Champions from Madhya Pradesh and Stories of Change from Odisha, Jharkhand and Assam. Aimed at capturing experiences, case studies and best practices at field level and communicating the same to relevant stakeholders for triggering actions the activities include mother's/women's groups meeting, documentation of success stories of local champions, letters shared from champions to policy makers in project states-Madhya Pradesh, Jharkhand, Odisha and Assam to generate demand for urgent action to treat SAM, engaging community (mother's, women self-help groups). The letters from the Nutrition Champions from the state of Madhya Pradesh have also been prepared and sent to the key stakeholders between March to December 2021.

Developing a Result-based work plan for the NCE phase of the program

The result-based work plan developed in the NCE phase of the project includes activities planned to ensure stakeholder and message alignment, and extends from February 12, 2022 to July 31, 2022. Membership engagement, knowledge management and pro-poor public policy are the key deliverables, in addition to organizing consultations, dialogues, creating a Charter of Demands; KOF mapping, membership engagement meetings and summarizing the THR mapping activity. Engagement with elected representatives and senior government functionaries is also planned.

CFNS has engaged with different stakeholders, CSOs, academicians, Centre of Excellence, State WCD and Health Departments, other Departments and Ministries, influential parliamentarians, therefore the effort is towards strengthening these engagements and influencing the policy leaders in guidelines and protocols pertaining to the community-based management of acute malnutrition. CFNS is working in tandem with State UNICEF offices for joint advocacy with the Government counterparts and other key stakeholders.

Roadmap to the Future

The first quarter of 2022, involved a series of activities and discussions on organising State Consultations on addressing wasting in Odisha, Assam, Madhya Pradesh and Jharkhand. CFNS executed the planning process required for the state consultations that involved engaging with the key opinion formers, governments etc.

Carrying forth the advocacy efforts on mainstreaming community management of acute malnutrition (CMAM), CFNS will be organising a high-level National Consultation on CMAM.

The Coalition is also actively engaging with public sector and CSR bodies to keep the spotlight on nutrition issues and invest in the wellbeing of the country's 7.7% wasted children.

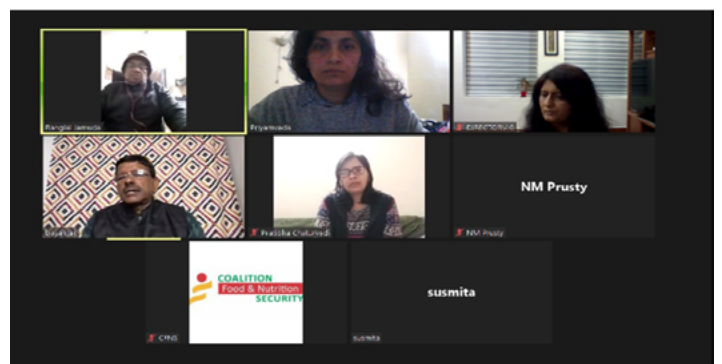
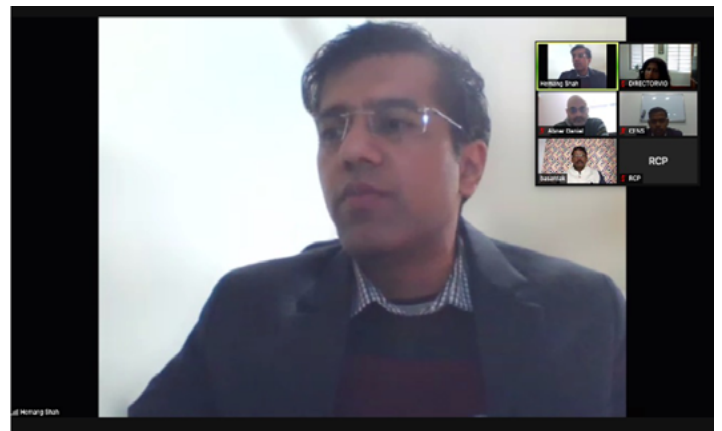
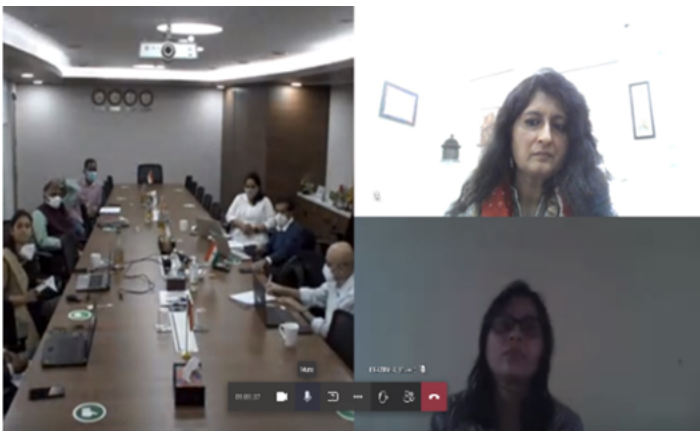

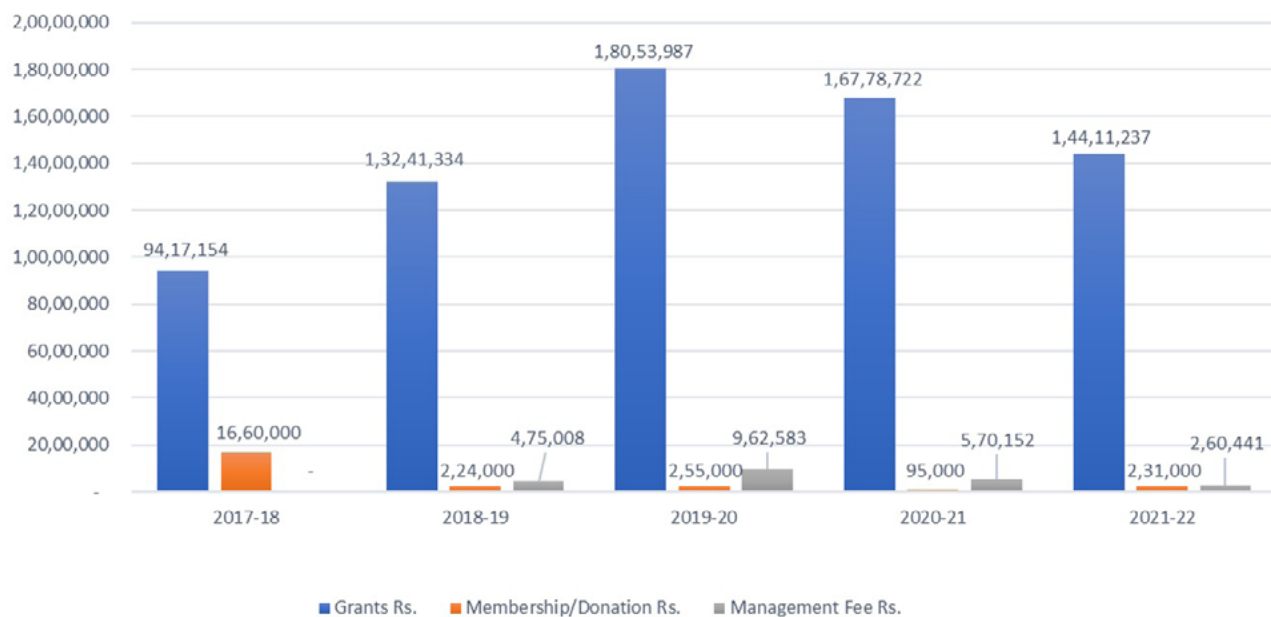

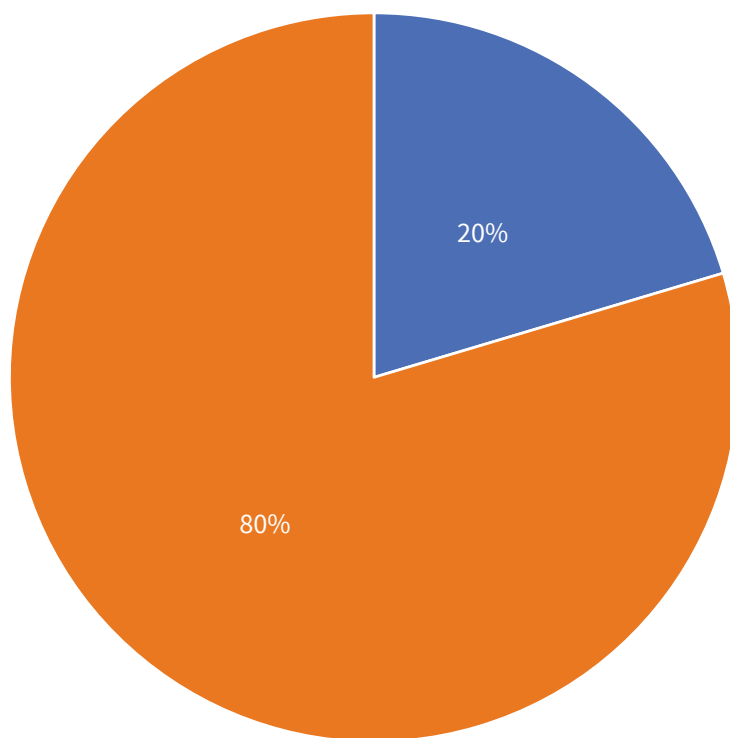
