CFNS Strategy

Introduction

The Coalition in its second decade is a platform for members to collaborate and achieve the common vision of "sustainable food and nutrition security for all." Unique and unparalleled, the Coalition has elected a Governing Board which includes senior functionaries from the Government of India, State governments and eminent civil society leaders.

The Coalition has the inherent strength as a public interest-oriented organisation to transform the food and nutrition landscape. This strategy aims to transform the country's nutrition scenario through collective action, keeping sustainability as the key approach, placing women and girls in the forefront. The methodology involves a series of consultations, in- depth interviews, feedback from the thought leaders and practitioners from across India and the world, discussion and approval in the General Body.

The Coalition functions as a knowledge aggregator, collating existing research coupled with on-field programs, and transferring the knowledge to partners and stakeholders. The Coalition strategy involves collaboration, influencing policy for improving state accountability vis-a-vis SDG targets, and providing informed choices on policy reforms, breakthrough research, and strategic priorities in its pursuit of evidence-based advocacy. These have been achieved by sustained and inclusive membership engagement, knowledge management designed for advocacy and to catalyse social behaviour change.

Our strategy for the next 5 years will be to ensure that sustainable food and nutrition is a priority agenda not only for the government, civil society and other development actors, but also for the socially responsible businesses, media, aid agencies and citizens at large, particularly the women and girls. Guided by the belief that women play a strategic role in protecting food and nutrition sovereignty, we will work to empower women with research backed information, tools and methods to bring changes in their human conditions and social positions. The Coalition will be guided by the concern that even as the increasing food demand is met, the natural resources will be used responsibly.





Highlights of the year 2023-2024

Policy Dialogues/Round Tables/Consultations

1.Odisha Round Table conducted on 7 August, 2023

The state consultation on the theme "Addressing Maternal Nutrition & Management of Low Birth Weight in Odisha" was organized by CFNS in collaboration with UNICEF and CYSD. Several Government representatives, development partners, CSR heads, civil society organizations and academic and research institutes participated in the state roundtable. Shri Abanikant Sahoo, Chairperson Odisha State Food Commission was the Chief Guest. Recommendations of the round table were finalised and shared with the Chief Secretary and Principal Secretary, Department of Health and Department of Women and Child Development, Odisha.



2.Madhya Pradesh Round Table conducted on 19 January , 2024

CFNS Madhya PradeshChapter organized a State Round Table on "Dissemination of Best Practices of Community based management of severe acute malnutrition" on 19th January 2024. The objective of the roundtable was toacknowledge the importance of sharing successful experiences and disseminating best practices to enhance the collective responseto children with SAM by facilitating an exchange of effective strategies among participants including government departments, CSOs, CSRs, NGOs, and Development Partners. During the roundtable, key insightsinto best practiceswere presented by the Government of Rajasthan and Odisha, GIZ Maharashtra, development partnersAmerican India Foundation and Darshna MahilaKalyan Samiti of Madhya Pradesh, and the National Institute of Nutrition, Telangana. The consultation was attended by the senior officials from the Department of Women and Child Development (DWCD) and Department of Madhya Pradesh. Health. Draft recommendations were jointly finalised with UNICEF and the same was shared with the Coalition members for their input before sharing with the Government of Madhya Pradesh..



3. Rajasthan Round Table conducted on 15 February, 2024

CFNS Rajasthan Chapter organized a State Round Table on 15th February 2024 on the topic "Enhancing Protein content through milk-based protein for SAM in Rajasthan". Under the chairmanship of Dr. Mohan Lal Yadav IAS, Secretary WCD Department Government of Rajasthan Government, the roundtable was aimed to facilitate discussions and initiatives for the pressing issue. During the event development partners such as Jhpiego, Ipas, Nutrition International, Dhara Sansthan, Vatsalya, World Food Program, Praytana Sanstha, IPE Global, Action Against Hunger, Additional Director ICDS Mr. Rajmal Verma, Deputy Director Dr. Manju Yadav, Disha Samit NGO, Center of Excellence(COE) and other development partners participated in the Round Table. Apart from this various government representatives from Gujrat, Odisha, Jharkhand and Telangana participated in the deliberations. Draft recommendations were finalized by the CFNS team and shared with UNICEF for their input.



4. Facilitation of the Odisha Vikash Conclave-2023 held on 6th-8th December, 2023

CFNS Odisha Chapter led the Technical Thematic Session on Health & Nutrition in Odisha Vikash Conclave -2023. The theme of the Odisha Vikash Conclave was "Demographic & Development Transition in Odisha: 2036". CFNS developed the policy brief, with some key policy asks for combating malnutrition and addressing maternal child and adolescent health & nutrition issues.



5. National CSR Consultation

CFNS team in collaboration with UNICEF and I4N worked on conceptualizing and designing a policy brief (flyer) "Collaborating for improving nutrition scenario: Taking forward the vision of POSHAN 2.0" that was released in the national round table "Investment case for Nutrition in Aspirational Blocks" organized by IMPAct4Nutrition, UNICEF along with IICA, CFNS and, CIFF on 17th November 2023 in New Delhi.



6. Facilitation of Partners meeting in Jharkhand

CFNS Jharkhand Chapter facilitated and hosted the partners meet **on** 'Strengthening Nutrition Together: A Collaborative Approach for CMAM SAMMAR in Jharkhand' on22nd December '23. The discussions in the partners meet emphasised on the need to

- 1.familiarize stakeholders with national CMAM guidelines to ensure a unified understanding of recommended approaches,
- 2. Identify and assess key stakeholders involved in food and nutrition security to develop effective partnerships and coordination mechanisms.
- 3. Facilitate the integration of new organizations into the CMAM SAMMAR program through orientation and support.





7. Collaborations

- 1.CFNS engaged with the Department of Agriculture, Government of Odisha to jointly work towards strengthening OMM's initiatives, disseminating case studies for replication and scale up at national level and among other states, empowering tribal women farmers and small holder farmers, facilitate building Millet led Local Food System, capacity building & Institutional development support extending and catalyst services for creating and strengthening sustainable Farmer Producer Organizations.
- 2.CFNS engaged with the Department of Agriculture, Government of Assam to jointly work in collaboration, along with Watershed SupportServices and Activity Network (WASSAN) on the comprehensiverevival of Millets under Assam Millets Mission.
- 3.CFNS team facilitated a training session on Institutional Building Approach for the Board Members and filed functionaries of Grihaluxmi Cooperative along with officials of Tata Steel Foundation and Access Development. lt was а two-day workshoporganized by Tata Steel Foundation with the objectiveto enable the participants to recognizeand commit to adopting the 'Institution BuildingApproach' rather thanproject mode in creating a member-owned enterprise.
- 4.CFNS team visited Deepak Foundation in Vadodara, Gujarat for programme expansion to explore the opportunities in food and nutrition security. A large group interactive process was held with the Chief Executive Officers & the Board of Directors 12 FPOs (both Farmer Producer of Companies and Farmer Co- operatives). CFNS and DeepakFoundation agreed to work togetherto strengthen the FPO's promoted by Deepak Foundation. Deepak Foundation has also agreed to host the CFNS GujaratChapter.
- 5.CFNS Odisha chapter initiated its efforts towards collaborative action with National Rice Research Institute, Cuttack for joint and convergent action in terms of developing knowledge products and documenting success stories. A draft MoU was prepared and shared with NRRI for consideration



District Need Assessment Study

CFNS Odisha, Madhya Pradesh, Rajasthan, Telangana and Jharkhand chapters conducted a need assessment study to identify the gaps and challenges in addressing growth faltering in the respectives states. The study looked at the trends and district wise disparities of child undernutrition in the above mentioned states.

Other Activities



- 1.CFNS national team organized a webinar on the theme "Enabling a Safer Environment for Breastfeeding" on 4th August, 2023.
- 2.CFNS Odisha chapter organized a webinar to celebrate the National Nutrition Month on 8th September on the theme "Nutrition for All: Together Towards a Healthy India".
- 3.CFNS Odisha Chapter organized a webinar on 16th October, 2023 World Food Day on the theme "Water is Life, Water is Food: Leave no one behind." The objective of the webinar was to engage multi stakeholders and push them to create evidence on food insecurity, poverty and addressing hunger in Odisha through policy reflections.
- 4.CFNS organized three lectures under the Lecture Series on "Producer Company: An Innovative Institutional Framework for Sustainable and Scalable Farmer Owned Enterprises".
- 5.CFNS was invited by the Government of Odisha to participate in the International Convention on Millets in the year 2023, the International Year of Millet. CFNS emphasized on the need for a collaborative approach of the three key actors namely Samaaj, Sarkar and Bazaar for promoting millet (SriAnna) as super food.

Working Group Delibertaion

The Working Group deliberation on Food Security and Climate Change was held on 5th October, 2023 at the EFFICOR Office in Delhi. The group deliberated on the pressing climate issues and its impact on food and nutrition security
